



## Defra Red Tape Challenge Regulatory Reforms

### April 2011 to May 2015

Actions relating to a total 655 Acts or regulations will be completed. These include 289 regulations which have been improved either through simplification without lowering standards or by consolidation and 316 regulations which have been revoked because they are no longer required. A further 50 regulations reviewed no longer have any legal force by implicit revocation and will be annotated as such on legislation.gov.uk by May 2015.
