MEMORANDUM ON THE APPLICATION OF STANDING ORDER 83L OF THE STANDING ORDERS OF THE HOUSE OF COMMONS RELATING TO PUBLIC BUSINESS TO THE BANK OF ENGLAND AND FINANCIAL SERVICES BILL (LORDS)

Commons Stage Report Amendments

The following is the Department's assessment of the Bill and the amendments to the Bill tabled by the Government for consideration at Commons Report stage.

Summary

- 1. The Bill's provisions extend to the whole of the United Kingdom, with the exception of clause 31(2), which extends to England and Wales and Scotland, and clause 31(3), which extends to Northern Ireland. The government amendments proposed for Report (amendment 3 and Government New Clause) apply to the whole of the United Kingdom.
- 2. In the Department's view, the matters to which the Bill and the amendments relate are not within the legislative competence of the Scottish Parliament, the National Assembly for Wales or the Northern Ireland Assembly, and no legislative consent motions are necessary.¹
