

# **CRIME (OVERSEAS PRODUCTION ORDERS) BILL: MEMORANDUM ON THE APPLICATION OF STANDING ORDER 83L OF THE STANDING ORDERS OF THE HOUSE IN RESPECT OF THE GOVERNMENT AMENDMENTS TABLED FOR COMMONS REPORT**

## **Summary**

1. With the exception of two consequential amendments, which have the same (limited) extent as the enactment being amended (as detailed in Annex A to the Explanatory Notes), the provisions of the Bill extend and apply to England and Wales, Scotland and Northern Ireland.

## **Commons Committee stage amendments**

2. For information, amendments made at Commons Committee stage applied the same application as the clauses they amended (i.e. to the whole of the UK) and did not alter the territorial application of the clause in question or the analysis at Annex A to the Explanatory Notes.

## **Commons Report stage amendments**

3. The following is the Department's assessment of the amendments to the Bill tabled by the Government for consideration at Commons Report stage.
4. The Government has tabled amendments to clauses 4, 6, 10, 12, 15 and 17. These amendments have the same application as the clauses they are amending, i.e. they apply to the whole of the UK. None of these amendments alter the territorial application of the clause in question or the analysis at Annex A to the Explanatory Notes.
5. New clause ("Designation of international agreements for purposes of section 52 of Investigatory Powers Act") applies to the whole of the UK.
6. The above assessment is presented in tabular form in the annex below.
