#### Professional Qualifications Bill: engagement with the devolved administrations

Thank you for your thoughtful and constructive contributions to the debate on the Professional Qualifications (PQ) Bill. I am writing to clarify the details of the engagement activity conducted with the DAs in relation to the PQ Bill and regarding the request for DA-BEIS correspondence to be published in the Parliamentary Library. These points were raised by both of you at Report Stage on 9 November.

My officials and I have engaged extensively with the DAs on the Professional Qualifications Bill. I have met all my ministerial counterparts and their predecessors, on a total of five separate occasions, to provide an overview of the Bill and discuss any areas of concern. My officials also work closely with their official counterparts in the devolved administrations and hold regular meetings with them. I know that they have already held meetings with each of the devolved administrations following Report stage to discuss next steps to securing legislative consent.

We have been open and transparent with the DAs from the outset and shared early drafts of the Bill, Explanatory Notes, and supporting documents. Communication channels are well established, and we have been open to discussing possible approaches to amending the Bill to meet concerns they have raised.

At every stage of the Bill's development and, indeed, its passage through Parliament, my officials have engaged with the devolved administrations. I was pleased that all three of the devolved administrations contributed to the department's Call for Evidence which ran from August to October 2020.

My officials and I have also engaged with a range of devolved regulators such as the General Teaching Council for Scotland, Law Society of Scotland, Social Care Wales and the Education Workforce Council and always keep DAs informed of, or in some cases directly involved in, these interactions.

I was disappointed that both the Welsh Government and Scottish Government have so far declined to grant legislative consent motions (LCM) for the Bill. I hope that we can continue to engage and persuade them of the merits of the government's approach.

I am attaching to this letter a summary of engagement with the devolved administrations inclusive of both ministerial and formal official level activity. At Report Stage you mentioned that the Constitution Committee would welcome such a document and I am therefore happy for this letter to be shared with the Committee for their views. You will appreciate that some of this engagement was held in confidence, and I would therefore be grateful if you do not circulate this further.

Finally, we cannot oblige on your request for my correspondence on the Bill to be shared to the parliamentary library. These letters often include matters wider than the PQ Bill as well as details of ongoing LCM negotiations. I would not want to break any confidences with the DAs, nor would I want to set a precedent for other Bills to provide this.

I am firmly committed to our Union and to a partnership of the nations that form it. As I made clear at Report Stage, the government will continue to work closely with the devolved administrations as the Bill progresses through Parliament to try to secure their support for granting legislative consent.

A copy of this letter will be deposited in the libraries of the House.
