## March - November comparison table

*The November restrictions contain an expanded set of exemptions compared with March. Almost all of these exemptions derive from amendments made to the March restrictions in April, May and June, as well as local interventions since, responding to practical needs or balancing the needs of wider public health and wellbeing against the threat of the virus.*

## List of restrictions, closures and exemptions

### 1. Exemptions

**Stay at home exemptions** No person may leave or be outside of their home without a reasonable excuse (unless they are homeless). A reasonable excuse includes the following:

Where it is reasonably necessary in order..

1. To buy goods or obtains services from relevant open businesses for your own household, for a vulnerable person, or for someone in the same household as a vulnerable person
2. To obtain or deposit money to/from a relevant financial services provider
3. To exercise or visit a public outdoor place for recreation or exercise (alone, in your household or support/childcare bubble, or with one other person)
4. To attend a place of worship
5. To attend a permitted Remembrance Sunday event, or specified Armistice day event in Westminster Abbey
6. Activities related to the purchase, sale, letting or rental of a residential property (or associated activities including visiting estate agents, viewing properties, preparing properties to move in)
7. To meet or visit someone in your support bubble
8. To collect ordered food and drink ordered from a business
9. To visit waste disposal or recycling centres

Work and other obligations;

10. Where necessary for the purposes of work or voluntary or charitable services, where it is not reasonably possible to work or provide these services from home.
11. To access voluntary and charitable services, such as food banks.
12. For the purposes of education or training

13. To provide care or assistance to a vulnerable person
14. To provide emergency assistance to any person
15. To fulfil a legal obligation e.g. attending court, satisfying bail conditions, or participating in legal proceedings
16. To access critical public services, such as social services, services provided by DWP, services provided to victims (would also include e.g. registering a birth). FYI- this is a non-exhaustive list.

#### Elite athletes

17. To participate in an elite sport event or training if you are an elite sports person, a coach, or a parent if the sports person is under 18

#### For a medical need

18. To seek medical assistance, including to take a test or to be vaccinated
19. To donate blood or attend medical trials
20. To avoid illness, injury or to escape a risk of harm
21. to attend a person giving birth at their request
22. to visit a person in hospital/hospice/care home, or to accompany someone to a medical appointment as a family or friend of that person

#### For support and respite

23. To attend a support group
24. for the purposes of respite care for a vulnerable person, a person with a disability, or a short break in respect of a looked after child

#### Deathbed visits

25. To visit someone reasonably believed to be dying where that person is a member of the household, close family, or friend.

#### Funerals

26. To attend a funeral
27. A commemorative event celebrating the life of a person who has died.
28. To visit a burial ground or remembrance garden to pay respect to a member of that person's household, family or friend.

### Marriage and civil partnerships

29. To attend a deathbed wedding

### Children

30. To continue existing arrangements for access to and contact between parents and children where they live apart
31. To arrange contact between siblings where they don't live together and one or more sibling is in formal care
32. To meet prospective adopters if relevant
33. To access educational facility, or to accompany a child to those facilities as a parent/carer
34. To access Ofsted registered childcare or supervised activities for children to enable a parent to work/undertake education or training/seek work
35. For the purposes of informal childcare provided within a childcare bubble

### Animal welfare

36. To attend veterinary services to seek advice about the health or welfare of a pet or other animal in care of that person, or to seek treatment
37. to attend to the care or exercise of a pet or other animal cared for by that person

### Other reasons

38. Where reasonably necessary to return home if you were on holiday immediately before the regulations came into force
39. To visit someone living in criminal justice accommodation if you are a friend or family member

### **Gatherings exemptions**

This provision specifies that no person can partake in a gathering which consists of more than two people, unless subject to exemptions.

The provisions around outdoor exercise and recreation will apply to public places, open country, highways etc. as well as botanical gardens and the grounds of other attractions - such as heritage sites or castles (indoor elements must remain closed).

Children under 5 and disabled people requiring a carer (continuous care) will not count towards the limit specified below of two people meeting in public open space for the purposes of exercise and open air recreation.

#### Same or linked households

1. People from the same household
2. People from the same support bubble
3. Childcare bubbles - where necessary to provide care for a child who is under 14
4. To continue existing arrangements for access to and contact between parents and children where they live apart
5. For exercise/open-air recreation (limited to one household/bubble/childcare bubble, or two people)

#### Work and other obligations - where reasonably necessary

6. For work purposes or the provision of charitable and voluntary services
7. For the purposes of education or training
8. To provide emergency assistance
9. To enable one or more persons to avoid injury or illness or escape risk of harm
10. To provide care or assistance to a vulnerable person
11. To facilitate a house move

#### Legal obligations and proceedings

12. To fulfill a legal obligation or participate in legal proceeding
13. Gatherings in criminal justice accommodation (e.g. prisons)

#### Support Groups

14. The gathering is for a support group (including, but not limited to, for victims of crimes, recovering from addictions, new parents, carers, LGBT support, bereavement, vulnerable young people) of up to 15 people, it takes place outside the home and it is reasonably necessary for members of the group to be physically present. Children under 5 do not count as part of the 15.
15. Respite care provided for a vulnerable person or person with a disability, or a short break provided in respect of a looked after child



### Births and visiting people

16. Attending a birth at the person giving birth's request
17. Visiting someone receiving treatment in hospital, hospice or care home, or accompanying someone to a medical appointment (where the person is family, a household member or a friend).
18. To visit someone reasonably believed to be dying where that person is a member of the household, close family or friend
19. The gathering is for a deathbed wedding which consists of no more than 6 people, subject to a risk assessment

### Funerals or commemorative events

20. To attend a funeral of no more than 30 persons and takes place outside a private dwelling, subject to a risk assessment
21. To attend a commemorative event following a person's death (for instance a stone setting ceremony or ashes scattering) with no more than 15 persons outside a private dwelling, subject to a risk assessment.

### Elite athletes

22. To participate in an elite sport event or training (as above)

### Children

23. To continue existing arrangements for access to and contact between parents and children where they live apart
24. To arrange contact between siblings where they do not live in the same household and one or more siblings is in care
25. To meet prospective adopters if relevant
26. To access Ofsted registered childcare or supervised activities for children to enable a parent to work/undertake education or training/seek work

### Remembrance Sunday and Armistice day

27. The gathering is to commemorate Remembrance Sunday or Armistice day in Westminster Abbey on 11 November to commemorate the burial of the Unknown Soldier and is outside (not in a private dwelling), with people are there as
  - i) part of their work
  - ii) person providing voluntary services in connection with the event

- iii) members of the armed forces
- iv) veterans of the forces or their carers
- v) spectators present on their own or with their household/bubble.

This would be subject to a risk assessment.

### 3. Penalties

The fixed penalty for individual offences will start at £200 (reduced to £100 if paid within 14 days), doubling upon repeat offences up to £6,400.

The fixed penalty for business restriction offences Individual offences starts at £1000, and rising with each repeat offence to £10,000. A business can also be served with a prohibition notice where it is necessary for preventing a business from continuing to contravene a restriction or requirement.

The fixed penalty for hosting a gathering of over 30 people is £10,000.
