Paper Title: Move to UC Discovery progress

Issue: The programme board have requested a monthly update on progress of the Move to UC Discovery work.

Introduction

- 1. There are now over 1800 claimants that have been notified to Move to UC as part of Discovery.
- 2. The "Earliest Testable Service" service in Bolton and Medway is reaching its conclusion. 485 out of 499 have reached the end of the process (either through the claimant making a claim or through termination of legacy benefits).
- 3. Testing of the service expanded to Cornwall on 25 July, Harrow on 16 August and Northumberland 13 Sept.
- 4. A below the line paper is provided showing our readiness assessment against the readiness criteria.

Claim numbers in the ETS Service:

- 5. 499 Migration Notices were sent to single claimants. This included claimants with a range of legacy benefit combinations.
- 6. 485 of these have either claimed or had benefits terminated:
 - 431 claims have been made (86%)
 - 355 made a claim before the original (3 month) deadline (71%)
 - 76 (15%) made a claim after their original deadline 56 (11%) of those claimed before their extended migration deadline
 - 78 Termination letters have been sent (of which 26 have subsequently made a claim). Next step is to understand why they didn't claim by interview.
- People were more likely to make their claim either in the first week or the last two weeks of the migration window – 71 claims were made in the week leading up to the original migration deadline.

Progress since the last board

- Based on the Programme Board's decision to focus our scaling efforts in 2023/4 on Tax Credit claimants, a number of Tax Credit only tests have been initiated. The full list of tests is provided below.
- 9. For the Echo cohort, we are introducing an SMS reminder a week before the deadline as the response rate has been much lower than other cohorts.
- 10. The Foxtrot cohort (for claimants in Northumberland) will be the last of the test groups runs in this fashion and we have now begun continuously notifying small numbers of Tax Creidt claimants to Move.
- 11. We have released the first version of the Move to UC web service which enables the Move to UC agents record and automatically inform UC when a MN has been sent, identify when someone has claimed UC and needs TP calculation activity, and allocate any Move to UC claims to Case Managers in the Move team.

Next steps

- 12. We are engaging with the new ministerial team on publishing some of the insights from the discovery tests as part of publically setting out our plans for 2023.
- 13. A further substantive paper is provided to the board outlining these plans.
