- **1. Expenditure Period**: The expenditure report encompasses the financial details from July 2024 to March 2025, outlining the costs incurred during this period.
- Maintenance Costs: For the Queen Elizabeth Class (QEC), Type 23 (T23), Type 45 (T45), Mine Countermeasure (MCM), and Landing Platform Dock (LPD) class of vessels, the maintenance costs considered include any expenses categorised as NACMO (Net Additional Costs of Military Operations).
- **3. Exclusion of Enhancements Outside of Upkeep:** It is important to note that the costs associated with enhancements made to vessels outside of a scheduled Upkeep cycle are not included in the maintenance/upkeep figures for the QEC, T23, T45, MCM, and LPD class of vessels.
- 4. Maintenance Approach for Fast Boats/Patrol Boats: Fast Boats and Patrol Boats only undertake annual planned maintenance work, there are no upkeep packages of work unlike the larger vessels.

5. Submarine Figures: We do not disclose details of Submarine maintenance and upkeep costs, as such information could be used to undermine the operational security and capability of the Royal Navy.

I trust that this explains the position.
